

**AAA Auburn 10/27/18 Sweepstakes
Official Rules**

NO PURCHASE OR MEMBERSHIP NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. How to Enter. To enter the AAA Auburn 10/27/18 Sweepstakes (the “Sweepstakes”), eligible entrants must visit the AAA Auburn branch located at 2480 Grass Valley Highway, Auburn, CA 95603, during the Sweepstakes Period (as defined in 2 below), participate in the on-site activities designated by Sponsor, and fill out an entry form, including entrant’s first and last name, phone number and email address. **Limit: one (1) entry per person.**

All entries become the sole and exclusive property of AAA of Northern California, Nevada & Utah (“Sponsor”) and receipt of entries will not be acknowledged or returned. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible or garbled entries, which will be disqualified.

2. Start/End Dates. Sweepstakes begins at approximately 11:00 a.m. PT on October 27, 2018 and ends at approximately 1:30 p.m. PT on October 27, 2018 (the “Sweepstakes Period”).

3. Eligibility. Participation open only to legal residents of the State of California who are at least 18 years old as of date of entry. Employees, officers and directors of Sponsor and its respective parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of sweepstakes materials and their immediate family members (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/officers/directors are not eligible to enter. All federal, state and local laws and regulations apply.

4. Random Drawing/Odds. There will be four (4) drawings conducted during the Sweepstakes Period at times selected by Sponsor. Winners will be selected in a random drawing from all eligible entries received at the time of each drawing. Odds of winning depend on the number of eligible entries received for each drawing. Drawing will be conducted by Sponsor. Non-winning entries will roll over into subsequent drawings. By entering the Sweepstakes, entrants fully and unconditionally agree to be bound by these rules and the random drawing conducted by Sponsor, which will be final and binding in all matters relating to the Sweepstakes.

Hawaiian Vacation

- One (1) Hawaiian Vacation package from AAA. 6. Notification. Winner will be notified by announcement at the event immediately following each drawing and must be present in order to win the applicable Prize. The Grand Prize winner will be required to sign and return a Declaration of Eligibility and Liability/Publicity Release at the event in order to claim his/her prize. If any winner rejects his/her prize, is unwilling to sign the Declaration, or in the event of noncompliance with these Sweepstakes rules and requirements, such prize will be forfeited and an alternate winner will be selected from all remaining eligible entries (time permitting). By participating, entrants, and winners agree to release and hold harmless Sponsor, its affiliates, partners and promotion and advertising agencies and each of their respective parent companies, subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers and directors (collectively, the "Released Entities"), from any and all liability, for loss, harm, damage, injury, cost or expense whatsoever including without limitation, property damage, personal injury and/or death which may occur in connection with, preparation for, travel to, or participation in Sweepstakes, or possession, acceptance and/or use or misuse of prize or participation in any Sweepstakes-related activity and for any claims based on publicity rights, defamation or invasion of privacy and merchandise delivery. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Sweepstakes should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Sweepstakes. In such case, Sponsor may select the winner(s) from all eligible entries received prior to the occurrence of the interfering event. Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process or the operation of the Sweepstakes or web site. 9. Limitation of Liability; Disclaimer of Warranties. IN NO EVENT WILL THE RELEASED ENTITIES BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES ARISING OUT OF YOUR PARTICIPATION IN THE SWEEPSTAKES OR RECEIPT OR USE OF ANY PRIZE. IN NO EVENT SHALL THE RELEASED ENTITIES' TOTAL LIABILITY TO YOU FOR ALL DAMAGES, LOSSES, OR CAUSES OF ACTION EXCEED \$10. WITHOUT LIMITING THE FOREGOING, THIS SWEEPSTAKES AND ALL PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. 10. Disputes; Governing Law. The parties waive all rights to trial in any action or proceeding instituted in connection with these Official Rules, including, without limitation, the Sweepstakes. Any controversy or claim arising out of or relating to these Official Rules and/or the Sweepstakes shall be settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association. Any such controversy or claim shall be arbitrated on an individual basis, and shall not be

consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in the State of California.

THESE OFFICIAL RULES AND THE INTERPRETATION OF ITS TERMS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF CALIFORNIA WITHOUT REGARD TO ITS CONFLICTS OF LAWS RULES. For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Sweepstakes, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the state and federal courts located in or closest to the County of San Francisco in the State of California. The parties agree not to raise the defense of forum non conveniens.
